1. Cost of Living Crisis

Considering the cost-of-living crisis, the officers have been identifying local support for the community over the winter months. Research is ongoing and support is still being set-up, but we continue to update the Town Council website with information and links. To date we have identified chat groups to support mental health and loneliness, a warm space, food larders, children's clothes and toy swaps and signposting to advice towards cost of energy support, benefits and so on. I have identified further interest in setting up a warm space and potentially community fridges. Both Hampshire County Council (up to £5000) and New Forest District Council (up to £1000) now have funding for those looking to set up a warm space.

2. Socially prescribed cookery courses

Our socially prescribed cookery courses continue to be popular as we simultaneously run our 6th and 7th courses. Due to popularity, the courses are held both on a Wednesday morning and evening throughout November, allowing the classes to reach a larger number of people whilst providing greater option on timings and availability to the public. The classes are extending to one-off options, the first will be held on December 9th 10.30am – 1.30pm in which participants will learn how to prepare a low carb festive meal. It is very much hoped that funding can be obtained to continue beyond March 2023 when the current fund expires. We are waiting to hear on the submitted bid, on 16 September, to the SW Railway Customer and Communities Fund (CCIF) to win £15,000 that would enable us to extend the courses for a further year.

3. Shared Prosperity Fund

NFDC are waiting to hear on an application for the governments Shared Prosperity Fund, submitted earlier this year. The opportunity to bid for £1,000,000 funding over a three-year period would help to support communities, high street initiatives and opportunities for the deprived.

4. The Lions Club Christmas window dressing competition

I am delighted and honoured to be invited to help judge this year's Christmas window dressing competition with the Lions Club. It is an exciting opportunity and one that is very much up my street so thank you. This will also allow me to engage further with the community and business owners.

5. Our previous TDM's retirement

I would like to thank Suna King for supporting me over the past three months in handing over the role of Town Development Manager. I wish Suna well with her retirement at the end of this month.
