Environmental Stewardship Agreement Extension

A summary of the extension offer received from the RPA

On 19 January 2023 the RPA sent us an offer of extension on our HLS agreement until 31 August 2028 noting that the stewardship terms and conditions changed effective 1 January 2023.

The changes refer to HLS options removed from some sites from 31 August 2023, and HLS Options extended until 31 August 2028.

It should be noted that the offer letter includes the following:

"It is a legal commitment for you to carry out the ES and HLS options listed in Part 2a and 2b of your agreement. If you have grassland management as part of your agreement, you must meet the requirements in Part 6".

You must meet the following conditions

- Follow the general management prescriptions on all your agreement land, or as stated in your agreement. The general management prescriptions are set out in the relevant editions of the ES and HLS scheme handbooks and supplements.
- Do not accept any other public funding or enter into any other agreement which applies to the land or capital works covered by this agreement, without our written consent.
- Fulfil your responsibilities relevant to any land on the holding that is classified as lopen access land on a conclusive map, published in accordance with Part 1 of the Countryside and Rights of Way Act 2000.
- Allow any existing informal public access on the holding to continue.
- You must get written agreement from us and acknowledge the support of the IES scheme for any publicity, events, Information, or interpretative material on or about the agreement land.

You should read the relevant edition of the ES and HLS scheme handbooks and supplements, including the section called 'What additional requirements will apply to my agreement?' The relevant edition will be the one that was current on the start date of your original agreement. If you are unsure which edition forms part of your agreement, please contact us. You should also read your amended agreement terms and conditions that apply from 1 January 2023.

We have to confirm our agreement to the extension by 16 February 2023.

It is our recommendation to confirm the extension to the Entry Level and Higher Level Stewardship Agreeent AG00442760.

Declarations:

If this amendment relates to the extension of your ELS/HLS agreement then the following additional declarations apply.

- I/we undertake to manage the HLS environmental features in accordance with the appropriate specific prescriptions to achieve the 'indicators of success' as set out in Part 3 of this Agreement.
- I/we understand that if I/we do not comply with my/our requirements I/we may be considered in breach of my/our agreement and any payments received may be recovered and any future payments due may be withheld.
