Application no. 21/11702 – 1 person spoke for the application.

181. APOLOGIES

Cllrs Murrow and Tungate had tendered his apologies.

182. DECLARATIONS OF INTEREST

On behalf of the committee, the Chairman declared an interest in both application 21/11702 (Men's Shed) and tree application 22/0010 (23 Antler Drive) as were sited on Town Council managed land.

Cllr Samber declared an interest in application 21/11717 (52 Chestnut Avenue) as he was well known to the applicants. He completed a register sheet and took no part in the debate or vote.

183. MINUTES

It was RESOLVED:

That the minutes of the meeting held on 6 January 2022 be agreed by the Chairman as a correct record.

The Minutes were duly signed.

184. MATTERS ARISING

The meeting clerk advised that action point regarding the SLR (minute 179c) was in progress. Our contractors (Ampfield Traffic Consultants) had advised the new position was licensed and New Forest District Council were awaiting funding from Hampshire County Council.

187. NEIGHBOURHOOD PLAN

The Chairman stated that there was no verbal update to give at this time.

188. CORRESPONDENCE

a) Strategic Sites updates from New Forest District Council

b) New Forest Sportive – 21 May 2022

Cllr Tungate had spotted a sportive from organisation 'Beyond events' advertising on Facebook. The event had not so far been listed on the public register of events held by New Forest District Council so has been forwarded to them. Burley Villa Riding Stables had also been informed.

c) Planning Appeal Lodged

An appeal against a decision by New Forest National Park Authority has been lodged, regarding application 21/00401, new access at Longacres, Bashley Common Road. Anyone wishing to make representation should do so to the Planning Inspectorate by 23 February. Link https://acp.planninginspectorate.gov.uk

d) Planning Enforcement Complaint

A recent complaint had been received regarding outbuildings at 18 Cowper Avenue. The complaint has been forwarded to New Forest District Council Planning Enforcement and we await a case number.

e) Bashley Road bus stop/layby

The Chairman has advised that the layby north of the post office, used by the school bus and CANGO service, had recently had yellow lines painted within it. It had been informally serving as safe overflow car parking. The issue has been raised with Hampshire County Council.

f) Swallows Ridge, Osborne Road

Cllr Davies had received several communications from a local resident concerned about safe egress from the development. This included the need for greater visibility to cross the road, by removal of one parking space (west of entrance). It was also noted there were no designated crossing points. This had been previously raised with the Town Clerk who wrote to Hampshire Highways Assistant Director Tim Lawton on 14 January and was awaiting a reply.

Members stated that this highlighted the need to meet with Hampshire Highways and New Forest District Council as there were several issues within the town that needed resolution.

Several members stated they were currently dealing with highway related queries from residents concerned about safety.

g) '20 is plenty for us' campaign

Several members had been contacted by residents regarding information promoted by organisation '20 is plenty for us'. It is a not-for-profit organisation that formed in 2007 and does not represent a particular sector of society or mode of transport. The campaign is national with a regional focus.

It requests all parish and town councils in Hampshire progress a motion that the County Council should

- adopt a maximum 20 mph speed limit where most people live, shop, work or play and leave 30mph as an exception;
- ring fence monies so all signage, road marking etc are implemented county wide within 3 years.

The campaign organisers cite safety, the environment, public opinion, government strategy and affordability as the reasons it should progress. They have provided case studies and other information in terms of evidencing the claims.

A report was submitted for consideration at Hampshire Association of Local Council's AGM on 6 November, which looked at various pieces of evidence and publicly available reports. The report concluded that

Widespread adoption of 20mph speed limits, with or without traffic calming, will have no perceived or actual improvements in safety of walkers or cyclist and are potentially a much greater source of health hazards than accidents, for which there are much better techniques for avoidance and mitigation.

We therefore call upon Hampshire County Council as the Highways Authority to resist calls for adoption of 20mph speed limits unless it can be shown, on a case-by-case basis, that there is sufficient evidence that serious accidents and injuries will be significantly reduced as a result, and then only to restrict it to limited sections of affected roads rather than a blanket adoption.

The issue is on the agenda of the New Forest Association of Local Council's upcoming meeting 27 January. See action points below.

Members had a general discussion on where 20mph limit might be supported in the town, the climate impact of individual car driving compared to car share or public transport use where available, and the impact to removing previous freedoms of owning personal cars. The Car Parking and imminent Air Quality Supplementary Planning Documents from the District Council were also mentioned.

It was then agreed to await the outcome of the New Forest Association of Local Councils meeting next week.

189. <u>NEXT MEETING</u>

The next meeting will be held on 3 February 2022 at 6.30pm in the Town Hall.
