### 103. CORRESPONDENCE

### a) Cycle Hoops at Tesco Express, 25-27 Station Road

A copy email had been sent from David Orme to the Store Manager regarding the lack of cycle hoops when three had originally been fitted. A job has been logged with the Tesco maintenance team to remedy.

### b) Engleburn Care Home, Milford Road

H.R. Manager Claudia Stephan had presented information to the committee previously, concerned about the safety of road crossing with her walking group of vulnerable people. Contact was made to Hampshire Highways and they had recently responded, stating any change had to be evidenced by road casualty reduction figures. Their limited resources meant highest priority was given strictly to locations with a history of recurrent injury accidents and that this area of Milford Road was 'low priority' with its lack of evidence.

Cllr Maynard had contacted Ms Stephan regarding this outcome, and had suggested a warning sign be placed instead, in the hope it would slow traffic at the best position to cross.

#### c) Planning Appeal Lodged
