#### b) Strategic Site Update

New Forest District Council have conducted inspections on the Brockhills Lane housing site (SS10), known as Danes Park. They advise that

- Earthworks, installation of drainage, roadways, pathways and other infrastructure are happening across site
- Some roads are now hard surfaced, meaning dust levels are reduced
- Tree protection fencing is in situ across the site
- Plots 6, 7 and 155-159 are at foundation level
- Plots 2-5 and 160-164 are at ground floor level
- Plots 1 and 22 are ready to be made watertight
- Application 25/10742 for advertising signage is currently being considered.

We will receive further reports as inspections are conducted in the short, medium and long term.
