- iv) 23/11290 1a First Marine Avenue Demolish existing buildings and erect a 3-bed dwelling and garage £4,220.31
- v) 25/10491 1 Otters Walk Erect dwelling following demolition of existing (part-retrospective) £7,594.42
- vi) 20/11177 Chalfont House, 10 Marine Drive Demolition of existing property and construction of a replacement dwelling 2,797.20
