163. CORRESPONDENCE

a) Significant Cliff Fall

The District Council coastal protection team have advised that a significant fall had occurs w/e 14 December and as a result, the clifftop path from Taddiford Gap and the far east car park on Marine Drive had been closed.

Access has also been closed at the end of the path from Barton Common to prevent the path being accessed.

b) Brockhills Lane closures

The following notification has been received.

- 12 January to 6 February Temporary traffic lights are proposed, with no access restrictions.
- 9 February to 20 February Restricted access will be in place during a full closure, for water connection to be made to the strategic housing site.
- 23 February to 10 April Hollands Wood Drive will be shut from junctions of Brockhills Lane to Badgers Copse.

The bus company have been informed and a letter drop will advise all nearby residents.

c) New Tree Preservation Order

A woodland group to the south side of Spring Lane has been protected under order TPO/0021/25. It includes all trees within the demarked area, regardless of species.

d) Friendly Dog Club

The meeting clerk advised members that a set of plans had arrived from the Dog Club's architect. This followed a meeting held on 18 November with the architect, Angela Horsley, Estates and Facilities Manager Mark Jeffries and the meeting clerk. The plans were currently being reviewed ahead of submitting them for Planning Permission. The principle of a replacement building had been discussed by Amenities Committee some time ago.
